Complaint Investigation Narratives

10/19/2018 approximately 1055 hrs I arrived on site. I spoke with Sal Guazzo regarding the complaint. Mr. Guazzo and I inspected the items on the reduction rack of bakery items. All the items on the table were within the use by dates and appeared to be fresh. I also spoke with the bakery manager regarding the mark down procedure. Items are removed from regular stock two to three days prior to used by date and marked down to sell. The items are pull from selling floor at the business day of the sell by date. According to the establishments's records there 9 for these items that were marked down for quick sale. According the Mr. Guazzo the store had not been aware that there was an issue with any of the items sold. Departed site 1415 (Inspection was conducted).
