We have tabulated the bids received on Tuesday, May 7, 2024, with reference to the above captioned project and find the low bidder to be Suburban Disposal Inc., 54 Montesano Road, Fairfield, NJ 07004 in the amount of \$25,550,000.00 representing the bid amount for OPTION 3 (5 year) as requested by the Township. In accordance with legal precedence, the award for OPTION 3 is based on the lowest amount for the 5-year total, which remains to be Suburban Disposal Inc. A copy of the tabulation is enclosed for your review. Please see below for a clarification of the Bid Options:

OPTION 1	Solid waste and recycling collection in carts provided by the Township / no yard waste collection / for a period of three (3) years with two (2) one (1) year renewals
OPTION 2	Solid waste and recycling collection in carts provided by the Township / no yard waste collection / for a period of five (5) years
OPTION 3	Solid waste and recycling collection and yard waste collection by reservation in carts provided by the Township / for a period of three (3) years with two (2) one (1) year renewals
OPTION 4	Solid waste and recycling collection and yard waste collection by reservation in carts provided by the Township / for a period of five (5) years

Therefore, in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq, the contract should be awarded to the lowest responsible bidder, which appears to be Suburban Disposal Inc. The award should be contingent upon approval of your solicitor and monies being available.
