**WASHINGTON TOWNSHIP
GLOUCESTER COUNTY**

**RESOLUTION AWARDING A CONTRACT FOR SOLID WASTE AND RECYCLING
COLLECTION BEGINNING AUGUST 1, 2024 AND ENDING JULY 31, 2027**

WHEREAS, advertisement for bids for the provision of services for Solid Waste and Recycling Collection was duly published in the Newark Star-Ledger and the South Jersey Times; and

WHEREAS, bids were received and opened on May 7, 2024.; and

WHEREAS, the following bid was received for a three-year contract:

Suburban Disposal Inc.	\$ 15,266,000.00	\$5,088,667

WHEREAS, the bid proposal of Suburban Disposal Inc., 54 Montesano Road, Fairfield, NJ 07004 in the amount of \$ 15,266,000.00 for a three-year contract is the lowest responsible bid; and

WHEREAS, the award of the bid in the manner set forth above is necessary for the efficient operation of the Township of Washington.

NOW, THEREFORE, BE IT RESOLVED by the Township of Washington as follows:

1. The Mayor is authorized to sign a contract with of Suburban Disposal Inc., 54 Montesano Road, Fairfield, NJ 07004, on behalf of the Township of Washington, contingent upon the review and approval of the Township Solicitor.
2. The contract period shall be from August 1, 2024 to July 31, 2027 not to exceed \$15,266,000.00, with an option for two (2) one (1) year renewals, for a total over five (5) years not to exceed \$25,550,000.00.
3. The CFO has certified that funds are available in the 2024 budget in line item #4-01-26-305-000-001, entitled Trash Collection and subject to budgets adopted in subsequent years; and
4. Notice of the contract award shall be published in the South Jersey Times.

BE IT RESOLVED, this resolution was adopted at a meeting of the Township Council of the Township of Washington held on May 15, 2024 and shall take effect immediately.
