NARRATIVE

On January 25th, 2024 at approximately 03:07 hours, I, Ptlm. W. Kenney was on patrol utilizing unmarked patrol vehicle PD60 in the area of Marina Drive. As I was passing [REDACTED] Marina Drive, I received an ALPR alert for a white Nissan Sentra bearing New York Registration: [REDACTED]

I then positioned my patrol vehicle behind the stolen Nissan and notified Headquarters of my findings. Headquarters confirmed the vehicle to be stolen out of Woodbridge Township yesterday (01/24/2024) at 07:32 hours (NIC: [REDACTED]). It should be noted, Detective Williams pursued this vehicle yesterday (01/24/2024) at 03:20 hours prior to it being reported stolen. Reference Case#: 24004945 for further information. I exited my patrol vehicle and found the stolen Nissan to be unoccupied, with the doors locked; as if it was dropped off to be used at a later time. I was also notified that the suspect(s) who stole this vehicle had the key fob in their possession.

I had Headquarters reach out to Woodbridge Police Department and they advised that they will not be responding. I was then notified by Sgt. Depasquale that the Edison Detective Bureau will be doing surveillance on the vehicle in hopes of apprehending the suspect(s). I did surveillance on the stolen Nissan with Detective Parenty until my shift ended where I was relieved by Detective Mankad. The investigation was subsequently turned over to Detectives, Parenty and Mankad. Nothing further.
