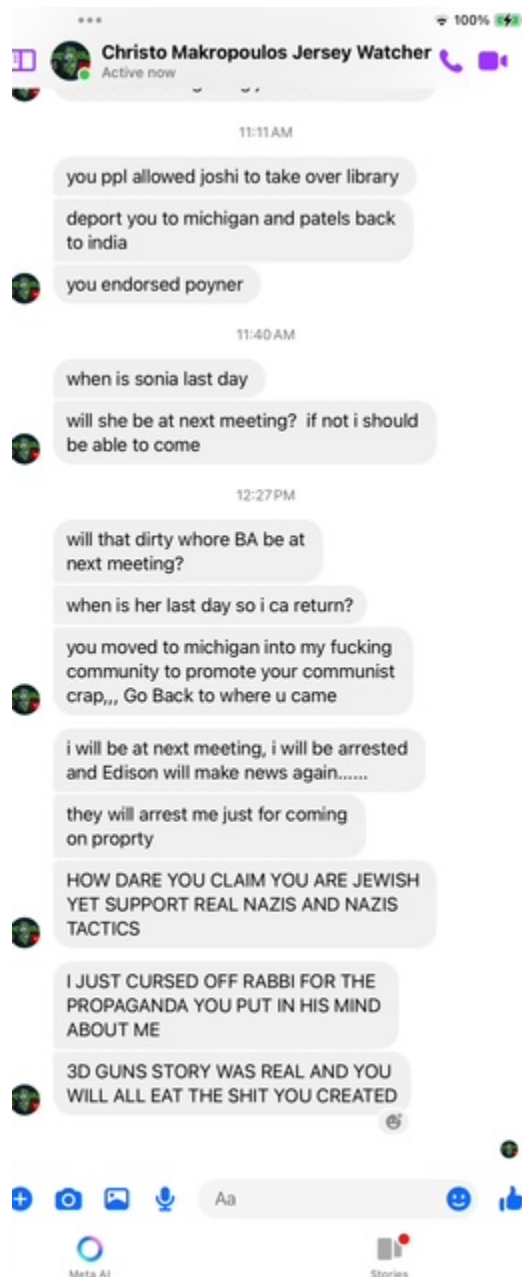

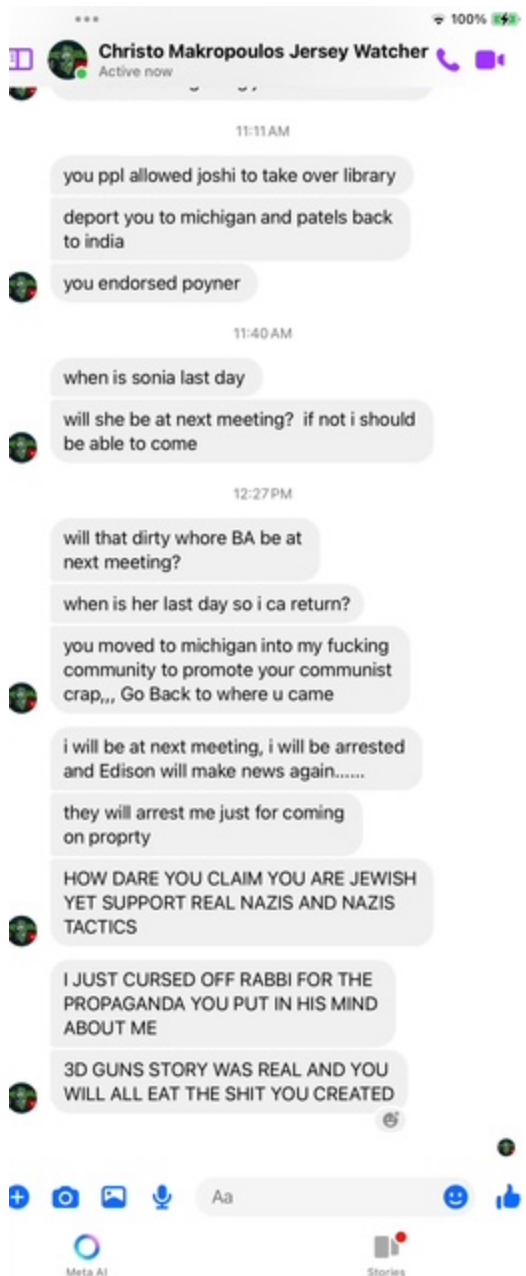

I am hereby submitting this **Tort Claim** in accordance with the **New Jersey Tort Claims Act** (N.J.S.A. 59:8-1 et seq.), in connection with an incident that occurred during a public meeting of the Edison Township Council on **September 9, 2024**. I was unlawfully removed from the meeting by **Council President Nish Patel** during the public comments period, solely for wearing a mask.

The actions of **Council President Nish Patel** and the Township Council violated my **First, Fourth, Fourteenth**, and **religious rights**, as follows:

1. Violation of First Amendment Rights:

The **First Amendment** of the U.S. Constitution protects my right to free speech and expression. I was participating in a public forum by speaking during the public comments portion of the meeting. The decision to remove me based on the fact that I was wearing a mask infringed upon my right to speak freely and engage in protected expression.

There is no law or rule of decorum in Edison Township that prohibits wearing a mask during public comments. Moreover, it is my understanding that the Township previously imposed mask mandates in the past, suggesting that wearing a mask is socially and legally acceptable.

2. Violation of Fourteenth Amendment Rights:

The **Fourteenth Amendment** guarantees equal protection under the law. I was denied the ability to participate in the public meeting solely because of my decision to wear a mask. This arbitrary action denied me the same rights and privileges afforded to other individuals attending the meeting.

3. Violation of Fourth Amendment Rights:

The **Fourth Amendment** protects citizens against unreasonable searches and seizures, including the protection of identity and privacy. My wearing of a mask is a personal decision to protect my face and identity, which I have a constitutional right to do. The removal of me from the meeting solely for wearing a mask, especially given that my face was being broadcast on live television, violated my right to privacy.

4. Violation of Religious Rights (New Jersey State Constitution):

Wearing this mask is an expression of my **religious beliefs**. I am asserting that the mask is a required part of my faith and religious practice. The actions taken by Council President Nish Patel constitute a violation of my **religious rights**, as

protected under both the **First Amendment** and the **New Jersey State Constitution**, which safeguards the free exercise of religion. Denying me the ability to express my religious beliefs through wearing a mask is a direct infringement on my constitutional rights.

Request for Relief:

I respectfully request that the following actions be taken:

1. **A formal apology** from Edison Township and Council President Nish Patel for the violation of my rights.
2. **A public assurance** that such violations will not occur in the future and that citizens will be able to freely express themselves at public meetings without fear of retaliation or unlawful removal.
3. **Consideration of other legal remedies**, including but not limited to compensation for the emotional distress and violation of my rights.

Please acknowledge receipt of this Tort Claim Notice and inform me of the next steps in this process. I would appreciate a prompt resolution of this matter, as well as any updates on the Township's position with respect to the violation of my constitutional and religious rights.

I am hereby submitting this **Tort Claim** in accordance with the **New Jersey Tort Claims Act** (N.J.S.A. 59:8-1 et seq.), in connection with an incident that occurred during a public meeting of the Edison Township Council on **September 9, 2024**. I was unlawfully removed from the meeting by **Council President Nish Patel** during the public comments period, solely for wearing a mask.

The actions of **Council President Nish Patel** and the Township Council violated my **First, Fourth, Fourteenth**, and **religious rights**, as follows:

1. Violation of First Amendment Rights:

The **First Amendment** of the U.S. Constitution protects my right to free speech and expression. I was participating in a public forum by speaking during the public comments portion of the meeting. The decision to remove me based on the fact that I was wearing a mask infringed upon my right to speak freely and engage in protected expression.

There is no law or rule of decorum in Edison Township that prohibits wearing a mask during public comments. Moreover, it is my understanding that the Township previously imposed mask mandates in the past, suggesting that wearing a mask is socially and legally acceptable.

2. Violation of Fourteenth Amendment Rights:

The **Fourteenth Amendment** guarantees equal protection under the law. I was denied the ability to participate in the public meeting solely because of my decision to wear a mask. This arbitrary action denied me the same rights and privileges afforded to other individuals attending the meeting.

3. Violation of Fourth Amendment Rights:

The **Fourth Amendment** protects citizens against unreasonable searches and seizures, including the protection of identity and privacy. My wearing of a mask is a personal decision to protect my face and identity, which I have a constitutional right to do. The removal of me from the meeting solely for wearing a mask, especially given that my face was being broadcast on live television, violated my right to privacy.

4. Violation of Religious Rights (New Jersey State Constitution):

Wearing this mask is an expression of my **religious beliefs**. I am asserting that the mask is a required part of my faith and religious practice. The actions taken by Council President Nish Patel constitute a violation of my **religious rights**, as protected under both the **First Amendment** and the **New Jersey State Constitution**, which safeguards the free exercise of religion. Denying me the ability to express my religious beliefs through wearing a mask is a direct infringement on my constitutional rights.

Request for Relief:

I respectfully request that the following actions be taken:

1. **A formal apology** from Edison Township and Council President Nish Patel for the violation of my rights.
2. **A public assurance** that such violations will not occur in the future and that citizens will be able to freely express themselves at public meetings without fear of retaliation or unlawful removal.
3. **Consideration of other legal remedies**, including but not limited to compensation for the emotional distress and violation of my rights.

Please acknowledge receipt of this Tort Claim Notice and inform me of the next steps in this process. I would appreciate a prompt resolution of this matter, as well as any updates on the Township's position with respect to the violation of my constitutional and religious rights.
