I have read the emails back and forth between you and my husband regarding his appearance in court on Monday. The attorney that was assigned Jason's case did not return Jason's calls and only responded to me when I copied him on an email to you asking Jason to call him when he has called him and the attorney never called him back.

This morning that pool attorneys secretary called Jason while we were dealing with our civil matter. That is extremely unprofessional after all the messages Jason has left for him. That being said Jason is not interested in having him as his legal counsel. Jason needs a professional that will fight for his rights, respond to calls in a timely manner and file appropriate motions promptly. The last pool attorney claimed she was working on the dismissal of these cases yet sent us nothing.

This morning we had court regarding our civil matter that our family has been involved in. That is the case that a Prosecutor from your County provided our adversary Jason's confidential records regarding his cases and documents outside the scope of the subpoena. All of this was previously mentioned to you and many others in emails that I have sent.

I also addressed the fact that JUDGE WALDMAN was not the Judge that released my husband from the Ocean County Jail. Judge Sandson was the Recovery Court judge at that time. So the court order dated 7/06/2020 that you sent my husband with Judge Waldman as the Judge and ordering pre trial monitoring in Ocean County is a bogus Order that was inputted into the system on 2022. Extremely unethical tactics on the part of the Atlantic County Court.

Furthermore, on October 24th you wrote to us stating who Jason's legal counsel is and you copied Emily Anderson from the Attorney Generals Office. Interestingly I received an unsigned letter from Ms. Anderson's department dated October 13, 2022 claiming that Jason had legal counsel therefore they would not communicate with us. Jason did not have legal counsel at that time as you are aware. It appears that everyone within the judicial system is doing everything they can to cover up all the mistakes made along the way.

Our family has had to focus on these cases and our civil litigation defending our positions without legal counsel. Jason's public defenders have done minimal to help him and the first pool attorney was caught in lies. If Jason cannot trust and rely on competent legal counsel then that too is a huge problem. I will now refer to a case that is in court right now that involves unscrupulous acts of the Public Defenders Office Docket No: MID-L-001526-18 Kevin Flood v. Public Defender Joseph Krakora, First Assistant Public Defender Kevin Walker, Assistant Public Defender Carl Herman, John Johnon, Office of the Public Defender-State of New Jersey, each in their official and individual capacities. That case outlines many issues with that office and it's employees relating to the payment and handling of cases.

I recommend that your vicinage look into the above mentioned case and the Prosecutor from your vicinage that leaked my husband's information to our adversary and most importantly look at that ORDER electronically signed by Judge Waldman dated July 7th, 2020 but not inputted into the system until 2022. Again, Judge Waldman was NOT the recovery court Judge that released Jason. I urge you to not ignore these facts.

I also most reiterate that OCEAN COUNTY is a complete conflict for Jason. Not just the Recovery Court Program as Ms. Toscano led all of you to believe. The conflict is with the vicinage and her department is a direct part of that vicinage. The fact that Jason's cases were sent back to a conflicted Vicinage for indictment without notice to the

defendant whatsoever is a violation of his rights. He was not offered the opportunity to object and give his reasons. Nor was the assignment Judge that transferred his cases ever contacted for clarification as to why his cases were transferred. The fact that Judge DeLury signed the transfer back to Ocean for indictments and didn't even bother to change the name on the order from Joseph to the correct name Jason Samaritano is disturbing. It is further disturbing that he is forcing Jason to come before him in court knowing all these conflicts exist.

A thorough investigation needs to be conducted into all of these issues. We will continue to seek out legal counsel outside of the Public Defenders Office. However, with extremely limited funds it has been difficult.

If this proceeding must happen on Monday I respectfully request on behalf of my husband for it to be via ZOOM until proper legal counsel is either provided by the state or we have obtained legal counsel on our own.

Thank you for your time and consideration. It is not our desire to be difficult. We just feel that the system has really taken advantage of my husband for far too long.

We were told that you were issuing a BENCH WARRANT if you didn't receive proof of Jason [REDACTED]. So here is proof. I don't lie. Which is something your vicinage should practice more. After all the proof I have provided to all of you about many of you being involved in collisional activities it amazes me that you would even consider a bench warrant over this.

Jason should NOT be before YOUR COURT after all you have done against simple rules of procedures. Here is the directive #11-18 model for the ORDER TRANSFERRING VENUE attached hereto for your review since all of you clearly ignore it. Court Rules have been broken, codes were broken, Policies, Procedures, Canons were violated, civil rights were violated and so forth.

Not one of you have been a stand up judge that has admitted there were mistakes and then tried to correct them. Instead you biasedly discriminate against a recovering addict and continue to kick him to the curb like a piece of garbage. That is not what the Recovery Court Program is about.

If you think for one second Jason is going to trust another attorney that you appoint him, think again. You know full well that Jason has charges filed against Deputy Defender Scott Sherwood. All pool attorneys have to go through him and nothing gets approved without his say so. He has denied important transcripts and withheld documents Jason needs from the get go. He even refused to allow Public Defender Laura Musarra's copies of Jason's discovery to be releases to Jason without removing items first. What could possibly need to be removed? She already had the copies done and set aside. Why would Mr. Sherwood need to even look through it?

The emails I provided earlier are just a few of many many more that I have obtained. If you can't see the lies, manipulation and straight up BS that Ms. Toscano gave to some of you directly then you are blind. She is a worse criminal than those behind bars because she abuses her power to place people in jail. Possibly some of

you are just as bad. Creating fraudulent ORDERS could certainly be a criminal act as I have been told. There was no reason whatsoever for that fake order to be created. It only made you all look malicious and more intentful.

Yes, my husband is upset and from what all of you have created. He has every reason to be upset and furious. You aided a conflicted Prosecutor right back into these cases. All he wanted was the discovery. Never did he refuse to plead out.

I have stated the conflicts with your venue now and you ignore it. You keep trying to move things forward as if what has gone on is no big deal. Well, it is a big deal. Many of these emails show a bias against Jason by several individuals within the judiciary. That is NOT the role of Judges and Prosecutor's to be bias. Where is your impartiality? This has to be moved out of your court. Look what has been created here. Jason didn't create it. All of you did by listening to an overzealous Prosecutor.

I am extremely frustrated with this judicial system right now. I can't even understand how none of you get where you have done wrong. You abused your power and authority. If Jason had a highly paid attorney I guarantee none of you would have pulled the stunts you have. You took advantage and that is so unethical, unprofessional, and again, an abuse of power. It also shows that you clearly know that any defendant with a public defender can easily be pushed around.

So to date here are the clear cut conflicts with your vicinage:

- 1) Two judges conspired with Ms. Toscano (DeLury & Walman)
- 2) Judge DeLury signed an Order 12/29/21 changing venue back to the conflicted county of Ocean for indictments by a conflicted Prosecutor.
- 3) Judge Waldman created a fraudulent order that he backdated to 7/6/20 and claimed that he was the drug court Judge at that time and stated in the order Jason was to do pre trial monitoring for the Ocean County cases in the conflicted Ocean County. Furthermore he was not the drug court Judge, Sandson was the judge.
- 4) Prosecutor's in your vicinage are extremely bias against Jason. One releases his confidential records to our adversary in a civil matter. Another won't give me information about investigating the Prosecutor that released those documents. The last Prosecutor is Lynn Heyer. Ms. Heyer's emails are filled with lies and she also colludes with Ms Toscano and reiterates her lies to several others in the judiciary.

Jason Wertzberger indicated that Jason would have to make an appearance before Judge DeLury and argue his position. We have already done that. Numerous times over and over we indicated the conflicts that have now been created by all of you, not Jason. You all choose to ignore as if you are above the law. You aren't above the law and I think it's time to straighten out our judiciary and hold all of you accountable. Your positions of power should never go to your heads and cause you to do illegal, unethical and unprofessional acts towards any defendant despite your feelings about them. Please read your Code Of Judicial Conduct again and refresh yourselves. While you're at it read the US Constitution and the NJ Constitution. All those documents seem to have slipped your minds.

You are all human beings, as are we. Nobody deserves to be treated how my husband has been treated. Wearing a robe or working in the system does not make you automatically exempt from prosecution. Immunity for all of you only goes so far and from what I can tell some of you have stepped over that line.

It was never my intent to get involved as I mentioned in a previous letter to all of you. However, you keep doing things that nobody in your positions should ever do. Maybe because we call it out it upsets you. Then

don't do to anyone what you wouldn't want done to you or one of your family members. That is a good rule of thumb. Defendants have rights like it or not. Nobody in the United States of America has the right to take those rights away.

You cannot expect judiciary staff to behave ethically when Judges, Prosecutor's, Team Leaders, Managers etc. are setting poor examples. This has to STOP! Treat everyone like they have top notch lawyer and stick to the rules and procedures yourselves. A person's financial status should not be the factor that decides whether or not they get pushed around and bullied by the system. Things have to change.

These Ocean County cases are absurd. One was remanded in 2017. Ms. Toscano recalled it to further harass my husband and pile more and more on him. Her unruly behavior towards my husband has included outbursts of laughter in the courtroom and her emails conspiring, manipulating and lying to get back into his cases are extremely disturbing. She is a true criminal and needs to be stopped in her tracks. A prosecutor that behaves this way now will only be so much worse as the years progress. It really is time for change.

A dismissal of these cases or a change of venue needs to happen. Do not keep bullying my husband to come back to your conflicted court and stand before conflicted judges. It's immoral to do so after all we have clearly pointed out over and over. I hope you understand now. We have had enough.
