ON 12/19/2021 AT 09:01 HOURS THE COMPLAINING OFFICER (C/O) RESPONDED TO COMMUNITY MEDICAL CENTER IN REFERENCE TO A DISORDERLY IN PROGRESS. INVESTIGATION REVEALED THAT THE DEFENDANT, KENNETH MILLROY JR, STRUCK THE VICTIM, ROBERT CROWLEY (SECURITY GUARD AT THE FACILITY) IN THE HEAD DURING AN ALTERCATION. Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On 12/19/2021 while working in the Watch Commanders office Kenneth Millroy, who had previously been released from the Toms River Municipal Jail and was no longer in police custody in any way, shape, or form, began knocking on the lobby window. I approached the lobby window. Mr. Millroy was upset that we were unable to transport him to Point Pleasant Beach at this time. He then threatened to tear the television screen in the lobby off of the wall. I advised him that if he damaged any property in the lobby he would be placed under arrest. Mr. Millroy acknowledged and calmly walked away.

After speaking with Mr. Millroy I began speaking with another party in the lobby at the window. While speaking I began hearing crashing sounds. I looked out into the lobby and Mr. Millroy was ripping the computer utilized for self-reporting out of the wall. He then smashed the monitor on the ground shattering it. I called downstairs to dispatch and advised them to send units. Based on his violent behavior in the lobby while in the company of several innocent bystanders I entered the lobby alone and commanded him to place his hands behind his back. I then advised him he was under arrest. He then threw the top of the "Stop" sign located in the lobby on the floor and complied by placing his hands behind his back. I handcuffed Mr. Millroy and advised him to move forward towards the door in front of him. Mr. Millroy continually shouted and used vulgar language.

I opened the door and began to escort Mr. Millroy to the Toms River Municipal Jail door. While escorting Mr. Millroy he continually pushed back all of his weight into me in and began to attempt to step backwards to prevent me from escorting him to the Toms River Municipal Jail. I commanded him to keep moving and he refused to comply. I lowered my shoulder onto his back and began to keep pushing him forward. When he reached the jail door he collapsed his legs. He was helped to his feet and escorted into Holding Cell 1. I completed a Use of Force Report.
