Purpose: This Affidavit/Certification is to more fully describe the facts of the alleged offense so that a judge or authorized judicial officer may determine probable cause.

1. Description of relevant facts and circumstances which support probable cause that (1) the offense(s) was committed and (2) the defendant is the one who committed it:

On this date, the NJSP Operational Dispatch Unit received numerous phone calls from independent witnesses advising that a male subject (vehicle operator) was actively striking a female victim (vehicle occupant) in the facial region during an apparent domestic violence incident while traveling on Interstate 195 WB in the area of Howell Township, Monmouth County. The physical attack progressed as witnesses observed the suspect stop within the right hand shoulder in the area of Jackson Township, Ocean County and forcibly remove the female from the vehicle. The actor then dragged her into the wood line and proceeded to manually strangle the victim. The suspect subsequently left the victim behind and re-entered the vehicle, identified as a 2013 black in color Hyundai Elantra bearing New Jersey registration [REDACTED]. The suspect began to flee the scene in the vehicle until suddenly changing directions, recklessly crossing the grass median and making a U-Turn into oncoming traffic utilizing the I-195 EB lanes of travel. He then traversed the center median a second time as witnesses observed the suspect accelerate toward the female victim and purposely strike same with the vehicle. The victim was impacted by the front bumper, hood, and ultimately, windshield of the vehicle. The suspect immediately exited and again forced the victim into the vehicle, continuing to travel westbound. Troopers assigned to NJSP Hamilton-Sub Station located the vehicle and subsequently conducted a Motor Vehicle Stop wherein the vehicle came to rest near Exit 5 in Hamilton Township, Mercer County. Troopers removed the operator from the vehicle and immediately effected the arrest of same. The suspect, identified as Steven McNeill, resisted arrest and while gaining compliance, Trooper Davidson sustained an injury to his right knee. McNeill was transported to NJSP Hamilton-Sub Station and the female occupant, identified as [REDACTED], was transported to Helene Fuld Medical Center reference medical treatment. Same sustained significant bodily injuries and will remain hospitalized, pending exhaustive testing. Members of Troop "C" CIO assigned to NJSP Hamilton-Sub Station responded to Helene Fuld and obtained a preliminary victim statement. Personnel from NJSP Crime Scene also responded to memorialize the victim's injuries. In addition, Hamilton Station detectives obtained formal witness statements which corroborated the victim's account of events. A TRO against McNeill was

requested and granted through the Howell Township Municipal Court. A Women's Space domestic violence representative responded to Helene Fuld as an advocate for Council. Monmouth County Prosecutor's Office was contacted and apprised of the circumstances surrounding the investigation. As a result of the case facts, first degree Attempted Murder charges were authorized by AP S. Dugan of the MCPO. McNeil was processed and subsequently transported to the Monmouth County Correctional Institute, pending a pre-detention hearing reference bail reform. At the time of this report's submission, multiple search warrant applications are pending for the suspect's vehicle, corresponding diagnostics, cellular devices, etc. Additional charges for Eluding, Resisting, Obstruction, Terroristic Threats and Criminal Mischief out of Hamilton Township, Mercer County are forthcoming.
