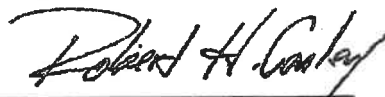

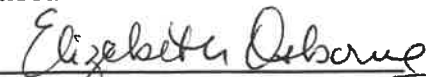
WHEREAS, Michael Pellessier has spent countless hours scheduling, coordinating and monitoring these Zoom meetings.
