Dear Town Resident:

This letter is in reply to your correspondence seeking certain records pursuant to the Open Public Records Act (“OPRA”), N.J.S.A. 47:1A-1 to 47:1A-13, and the common law right of access to public documents. The County of Union received your OPRA request on November 21, 2023, and forwarded it to the official Records Custodian of the Union County Prosecutor's Office on the same day. As such, the seven (7) business day deadline to respond is December 1, 2023. This response is being provided to you on the second business day after the custodian's receipt of your request. We appreciate your patience and understanding in awaiting our response.

Specifically, your OPRA request read as follows: “A copy of the criminal summon(es) served to Salvatore Bonaccorso of Clark, NJ mentioned in the Attorney General press conference on 11/20/23.”

Unfortunately, the Union County Prosecutor's Office has no records responsive to your request. Please note that the criminal summons served in this case came directly from the New Jersey Office of the Attorney General. We respectfully suggest that you re-submit your request to the Office of the Attorney General.

If your request for access to a government record has been denied or unfilled within the seven (7) business days required by law, you may challenge the decision of this Office to deny access by either instituting a proceeding in the Superior Court of New Jersey or filing a complaint with the Government Records Council (“GRC”). You may contact the GRC by telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ, 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc.

With this letter, the Union County Prosecutor's Office considers your OPRA request to be completed and closed.
