I am writing to follow up on notices (attached) that were mailed regarding overpayments of funds for Hurricane Sandy. Some of these projects have had multiple notices sent previously.

As per our records:

- Project #2117 has an overpayment of \$11,485.30.
- Project #1868 has an overpayment of \$13,724.31.
- Project #2472 has an overpayment of \$530.16.
- Project #2187 has an overpayment of \$1,557.45.
- Project #3145 has an overpayment of \$558,149.42.
- Project #2188 has an overpayment of \$283,093.92.

We kindly request an update on the status of the refund for the overpayment. If you have recently mailed the overpayment or taken steps to initiate the refund process, we would greatly appreciate receiving any details you can share.

Please note if a status is not provided in a timely manner, the situation will need to be escalated to the Office of the Attorney General. My goal is to work together to resolve this situation promptly and cooperatively.
