As you know from our previous email conversations, I am the Assistant Prosecutor in this office tasked with responding to public record requests. This letter serves as a response to the remainder of your records request from the above-date.

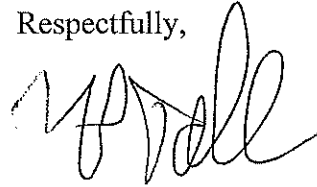
With respect to your request for a list of WCPO fleet vehicles, please find attached a list of this office's fleet vehicles. Please note, however, that this list omits vehicles used in undercover operations and other confidential investigations because such disclosure could compromise ongoing and future investigations; potentially reveal the identity of undercover officers and confidential informants or confidential sources; reveal surveillance, security, tactical, investigative and operational techniques, which if disclosed would create a risk to safety of persons, property and information or compromise the ability to effectively conduct investigations. These omissions are made pursuant to N.J.S.A. 47:1A-1.1 (10), ("Security measures and surveillance techniques which, if disclosed, would create a risk to the safety or persons, property, electronic data or software").

With respect to your question regarding cell phones and cellular plans utilized, attached please find a copy of monthly invoice's from Verizon; these invoices should reflect the service packages that Assistant Prosecutor's and detectives, respectively, are enrolled in. Also enclosed is a list of individuals within this office who utilize cellular telephone services. Individuals and phone lines utilized by undercover officers are likewise omitted as in the case above regarding the fleet vehicles. Please see N.J.S.A. 47:1A-5a.

Lastly, with respect to your records request regarding a "Table of Organization for the Warren County Prosecutor's Office", please be advised that we do not have such a document.
