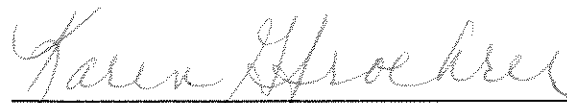
- 1. The number of teachers who have resigned or retired in the past two school years and any de-identified data of their exit interviews/reasons for leaving.*
