RESOLUTION APPROVING QUALIFIED VENDORS AND SERVICE PROVIDERS FOR PARKING SYSTEM MANAGEMENT CONSULTANT SERVICES ON AN AS- NEEDED BASIS

WHEREAS, in accordance with Municipal Codes Section 2:10-8, Plainfield instituted a policy to negotiate agreements for Professional services on the basis of demonstrated confidence and qualifications for specific types of Professional services required by the City; and

WHEREAS, the City has received in accordance with the notice published on February 8, 2023 sealed qualifications for Parking System Management Consultant Services within the City; and

WHEREAS, costs associated with this work will be dependent on the type of project, work solicited and or undertaken/completed and will be taken from appropriate accounts outlined in the 2023 City budget; and

WHEREAS, pursuant to the fair and open process, the Department of Economic Development, and the Purchasing Division has reviewed the qualifications and determined that the following firms are qualified to be awarded contracts to provide Parking System Management Consultant services on an as need basis for a period of one year or until completion of the work phases commencing January 1, 2023 and ending December 31, 2023;

NOW THEREFORE BE IT RESOLVED, that the City Council does hereby qualify the above-listed vendors to provide Parking System Management Consultant services to the City on an as-needed basis as approved by the Director of Department of Economic Development for a one-year period or the completion of the work commencing January 1, 2023 and ending December 31, 2023;

BE IT FURTHER RESOLVED, that this resolution shall take effect immediately; and

BE IT FURTHER RESOLVED, that a copy of this resolution shall be placed on file in the Office of the City Clerk.

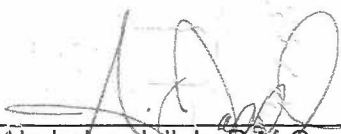
