On 03.23.2020 at approximately 1600 hours, this author was working in the capacity of the Watch Commander at District 1 (255 Oak Avenue). This author was notified that a prisoner in the Municipal Jail, David Giordano, while in the holding cell, punched a plexiglass partition between the holding cell and jail officers station. The reporting jail guard, Nick Malta, reported the plexiglass broken and damaged. This author personally observed the broken plexiglass and was determined to not be a hazard at the time of this report. The value to replace the plexiglass with installation is reported at 225.00. Complaints were completed by this author for Criminal Mischief 2C:17-3.
