

**MEMORANDUM OF AGREEMENT
BETWEEN THE COUNTY OF BURLINGTON AND PBA LOCAL #249**

The Board of Commissioners of the County of Burlington ("Burlington") and PBA Local #249 ("the Local") (collectively referred to as "the parties"), having engaged in collective negotiations, hereby mutually agree as follows with respect to modification of the terms of the Collective Negotiations Agreement, which expired on December 31, 2020.

1. The parties acknowledge the following facts:
 - a. After the expiration of the Collective Negotiations Agreement that had a start date of January 1, 2012 and an expiration date of December 31, 2020, the parties engaged in collective negotiations that failed to consummate a negotiated agreement.
 - b. Thereafter, the parties participated in an Interest Arbitration proceeding bearing NJPERC Interest Arbitration Docket Number 2021-023.
 - c. The Interest Arbitration was presided over by Interest Arbitrator Brian Kronick who rendered an Award dated January 19, 2022.
 - d. Subsequent to the award being rendered, the parties failed to agree on the Interpretation of the salary portion of the Interest Arbitrator's award that resulted in litigation bearing NJPERC Grievance Docket Number AR-2022-444 (Incorrect Pay Grievance) and NJPERC Scope of Negotiations Docket number SN-2022-040.
 - e. In an effort to resolve the litigation and for other good cause, the parties re-engaged in collective negotiations that has resulted in the following resolution:
2. **Expired Collective Negotiations Agreement:**
The terms of the prior 2012-2020 Collective Negotiations Agreement between the parties shall remain in full force and effect except as limited by the terms of that Agreement or as modified herein.
3. **Interest Arbitration Award 2021-023:**
The Interest Arbitration award bearing Interest Arbitration Docket Number 2021-023 shall remain in full force and effect except as modified herein.
4. **Duration and Renewal (Article XXXVII (37)):**
The term of the new Collective Negotiations Agreement shall be for a period of five (5) years, effective January 1, 2021 through December 31, 2025.

5. Salary (Article II (2)):

The Salary article shall be amended as follows:

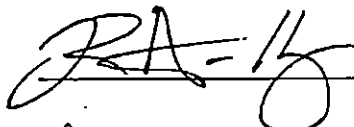
- a. The Salary Guide for this five (5) year agreement is appended hereto as Exhibit A.
- b. The annual movement for the Local's members on the salary guide and corresponding salary increases are reflected on the "movement chart" appended hereto as Exhibit B.
- c. On January 1, 2021, each Step on the salary guide was increased by two percent (2%).
- d. On January 1, 2022, each Step on the salary guide was increased by two and one quarter percent (2.25%). Immediately thereafter, all bargaining unit members who were not on the top step of the salary guide moved one (1) step on the salary guide.
- e. As part of the resolution of disputes under this Agreement, the Local agrees to accept all salary adjustments and payments made by the County to the Local's members for 2021 and 2022.
- f. On January 1, 2023, each step of the salary guide shall be increased by five thousand dollars (\$5,000.00). Subsequent to increasing each step of the salary guide by five thousand dollars (\$5,000.00), the top step on the salary guide (Step fifteen (15)) shall be increased by an additional two and three tenths percent (2.30%). Immediately thereafter, all bargaining unit members who are not on the top step of the salary guide shall move one (1) step on the salary guide.
- g. On January 1, 2024, each step on the salary guide shall be increased by two and one quarter percent (2.25%). Immediately thereafter, all bargaining unit members who are not on the top step of the salary guide shall move one (1) step on the salary guide.
- h. On January 1, 2025, each step on the salary guide shall be increased by two and one quarter percent (2.25%). Immediately thereafter, all bargaining unit members who are not on the top step of the salary guide shall move one (1) step on the salary guide.

6. Other Terms and Conditions –

- a. The litigation bearing NJPERC Grievance Docket Number AR-2022-444 (Incorrect Pay Grievance) shall be dismissed with prejudice with each party bearing their own costs and fees.

- b. The litigation bearing NJPERC Scope of Negotiations Docket Number SN-2022-040 shall be dismissed with prejudice with each party bearing their own costs and fees.
 - c. The litigation PBA Local 249 v. Burlington County, Custodian of Records, et als, bearing New Jersey Superior Court Docket Number Bur-L-1957-22 shall be dismissed with prejudice with each party bearing their own costs and fees. The corresponding OPRA request which was the basis of that lawsuit shall be withdrawn and abandoned. The Local shall file correspondence with the County Custodian of Records confirming such withdrawal. Furthermore, the one thousand dollar (\$1,000.00) fee for the production of documents that was advanced by the Local shall be refunded.
 - d. Any remaining requests that the Local may have made to the County and/or its subdivisions under the Open Public Records Act shall be withdrawn and abandoned. The Local shall file correspondence with the County Custodian of Records confirming such withdrawal.
7. This Memorandum of Agreement, together with the prior Collective Negotiations Agreement between the parties, and the Interest Arbitration Award bearing Docket Number IA-2021-023 represents the complete and final agreement between the parties, and is contingent upon ratification and approval of the Local's membership and the Burlington County Board of Commissioners.
8. All other proposals, whether written or oral, presented by the parties during course of negotiations are deemed withdrawn and are not a part of this Agreement.
9. This Agreement cannot be modified except by a writing signed by the parties.
