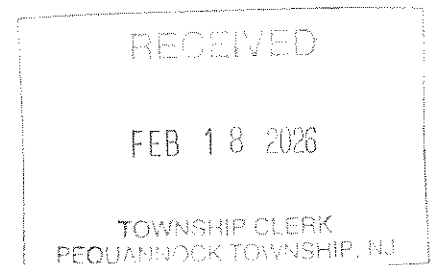
Dear Pequannock Township,

I AM NOT seeking records in connection with a legal proceeding.

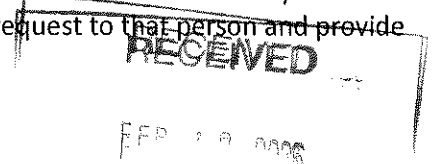


Records requested:
