CONCLUSIONS OF ROSSINI'S FINDINGS, SHE REVEALED THAT VEGA WAS ACH WIRING MULTIPLE AMOUNTS OF MONEY TO HER PERSONAL BANK ACCOUNT FRAUDULENTLY. OVER 32 TRANSACTIONS WERE MADE STARTING MARCH 7TH, 2023 AND CONCLUDING MAY 31ST, 2024. THE TOTAL OF THESE TRANSACTIONS COMES OUT TO \$99,342.69. VEGA DISGUISED THE TRANSACTIONS AS REIMBURSEMENTS, DUES, FEES AND ETC. BE ADVISED THAT VEGA WORKED IN THE OFFICE AS A BOOK KEEPER FROM MONDAY- THURSDAY AND REMOTELY WORKED FROM HOME ON FRIDAYS.

AT THE TIME OF THIS REPORT VEGA HAS NOT BEEN CONFRONTED ABOUT THE MISSING FUNDS BY MCBRIDE CORPORATE INC. VEGA HAS SINCE LEFT THE COMPANY AFTER A LAY OFF IN JUNE OF 2024 AND IS CURRENTLY EMPLOYED BY [REDACTED] ROSSINI HAS PROVIDED A DETAILED COPY OF BANK STATEMENTS AND A EXCEL SHEET OF FRAUDULENT TRANSACTIONS MADE BY VEGA. THESE COPIES CAN BE FOUND IN THE CASE FILE. NO FURTHER ACTION WAS TAKEN BY PATROL.

NARRATIVE (R) On September 11th, 2024, members of McBride Corporate Real Estate were present in police headquarters to report an act of fraud to their company by a previous employee. The majority owner, Michael McBride stated that his former employee, Maria Vega who was employed from 2019 until June 2024 as the company book keeper had redirected payments and reimbursements from other vendors into her personal checking account via direct deposits. Mr. McBride stated that the total loss came out to \$99,342.69 between the time frame of March 7, 2023 to May 31, 2024. He was advised that the matter would be handled by the detective bureau and to provide any more information discovered involving Ms. Vega. Detective Sergeant Shatkin and I began our investigation contacting Chase Bank and sent a subpoena for her checking account records. We spoke with McBride employee, Lauren Rossini who provided a detailed report of back end paperwork including all of Ms. Vega's payroll history. After further investigation into Ms. Vega's financial history, we concluded that the money taken from McBride Real Estate matched that of Ms. Vega's personal bank account deposits (Account number [REDACTED]). On Thursday, September 26th, DSG Shatkin and I responded to Ms. Vega's residence at [REDACTED] in [REDACTED] but were unsuccessful with making contact. We took notice that there was a 2021 Chevrolet Suburban parked near the residence which was registered to Ms. Vega but she was not present at the home. Moments later, DSG and I responded to Ms. Vega's place of work, [REDACTED] to make contact. When we arrived, contact was made with Ms. Vega and she was advised of the investigation. She agreed to be transported to police headquarters to speak with us about the investigation....

While at police headquarters, Ms. Vega was escorted to the conference room where she was advised that an interview would be conducted. DSG Shatkin provided Ms. Vega with a copy of the Rochelle Park Police Miranda Rights form and advised her that the interview would be recorded. Ms. Vega signed the Miranda Rights form stating that she understood her rights and agreed to be questioned without the presence of an attorney. A detailed interview was conducted with Ms. Vega which led to her admission of making multiple fraudulent transactions while working at McBride Corporate Real Estate. She confirmed that the Chase bank account matched that of her personal checking account and that she was solely responsible for redirecting the payments to her account. Ms. Vega stated that she was struggling to pay her bills as her son had been in an accident and that was her sole reason for committing her actions.

After the investigation was concluded, Ms. Vega was escorted into the processing room where she was photographed, fingerprinted, and fully processed. Contact was made with Assistant Prosecutor Nicole Patton who agreed that due to Ms. Vega's lack of criminal history, her charge would be placed on a summons. Ms. Vega was charged with Theft by Deception, 2C:20-4 (2nd degree) and provided a CJP court appearance of Friday, October 11th, at 0830 hours. She was given a copy of her charges, her belongings, and was released without incident.
