At 1831 hrs this date (4-22-89) Officer Geoghegan and this officer were dispatched to 1600 Mt Everest where Mrs Voigt reported that her husband shot him self.

Upon arrival at 1835 hrs officer Geoghegan stated that the victim had a weak pulse. This officer arrived at 1836 hrs. and observed the victim Carl Voigt seated on a couch in the den of his home with a large wound on the right side of his head. Mr. Voigt had a large caliber revolver in his right hand. Officer Geoghegan attempted to stop the victims bleeding (Cont)
