Mayor and Council met with me last evening and we discussed the issue of an emergency contract with Moorestown EMS and Palmyra EMS to provide coverage to Delran and discussed the relationship Delran EMS has with Riverside as well. We discussed the issues that we outlined in the meeting you attended with Moorestown and Palmyra on Friday July 20th 2018 and their offer of coverage in return for upfront payments of \$6200 combined Delran \$4,030 per week and Riverside \$2,170 per week with the billings to be returned to the Townships that are received from the respective calls. The Township Council authorized me to go forward to have the Township Solicitor to draft an agreement and I just need to know if you want to do this as a shared service agreement with Delran or do you wish to do individual agreements with each of the EMS groups directly. We are comfortable moving forward either way. I will need direction shortly as we need to begin authorizing payments to the squads as they indicated their largest concern was the upfront cost commitment. Please advise if you are moving forward with this agreement and if so which course of action you wish to take in terms of individual agreements and or an agreement with us acting to put it together.

Jeff Hatcher here hope you are doing well. I have been doing some research over the last week on emergency squads and your name and a report you did popped up on one of my searches and I wanted to ask you some questions. First of all do you have a couple minutes to talk later this week? My problem is this, we are serviced by the Delran Emergency Squad a private 501 3© that services Delran and Riverside Township. Monday July 9th State Board of Health Emergency Services Investigators came into my office and advised me that they were suspending the license of the squad immediately. They had contacted the County Emergency Services to provide mutual aid coverage for 48 hours to give us a little time to decided what to do (thanks). Anyway I convinced three area squads to continue to cover us for 30 days in exchange for the billings under mutual aid. However after one week they came in to report that the number of calls the Delran Emergency Squad was receiving must have been overstated significantly and that there were not enough calls to pay for their service with billables and that starting next week they needed to be paid a pretty significant amount of money. Obviously we don't know if we were bridging a month, a couple of months or more suspension, however the State Health Investigator advised me recently that now they were looking to revoke their license. Anyway I am looking at RFPs , there has been discussion of the Fire Commissioners trying to take it under their belt etc. and just want to consider all options. Seems like you have some experience in this area and wanted to pick your brain a couple minutes if you have time. If you have any ideas or references would love to hear them. Thanks in advance for considering this issue.

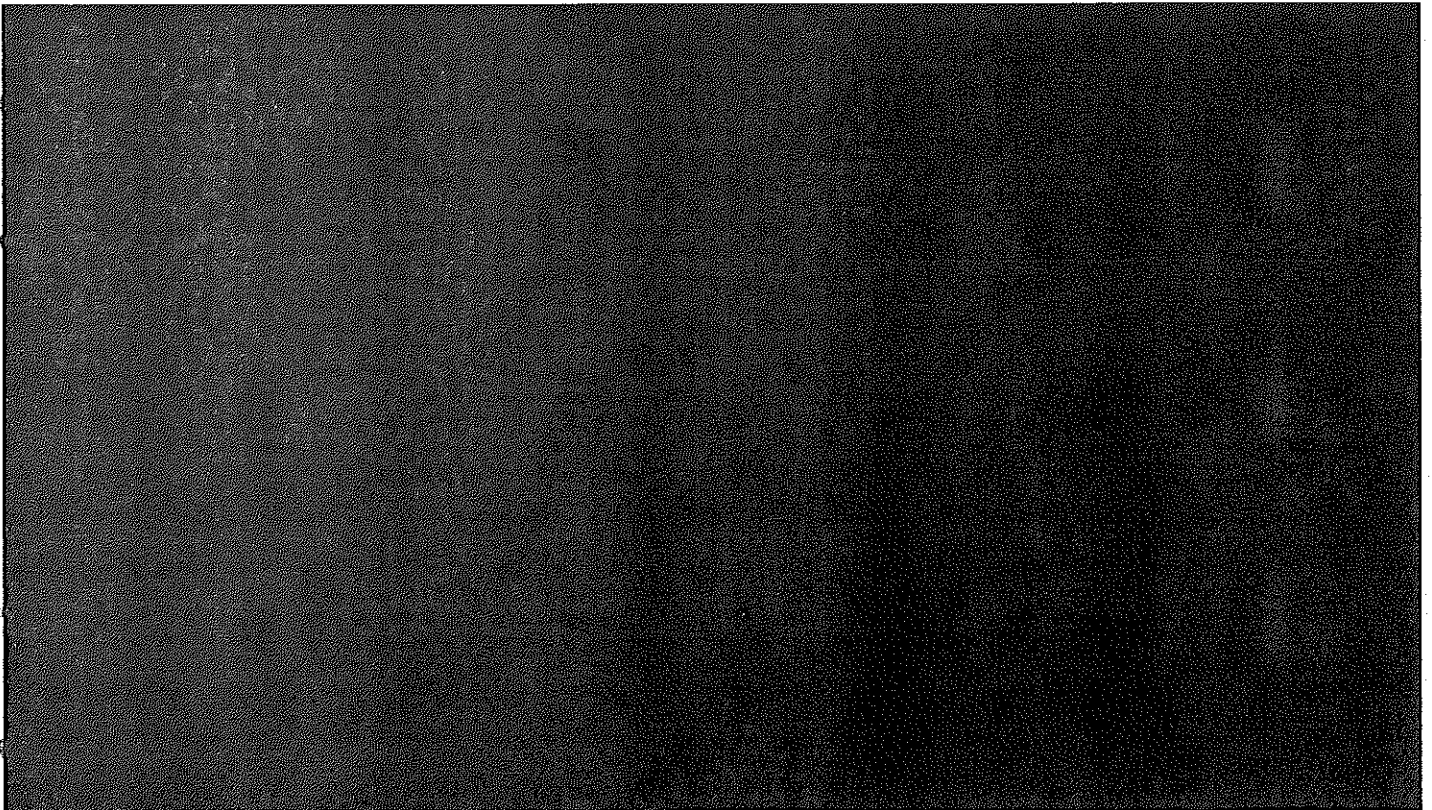

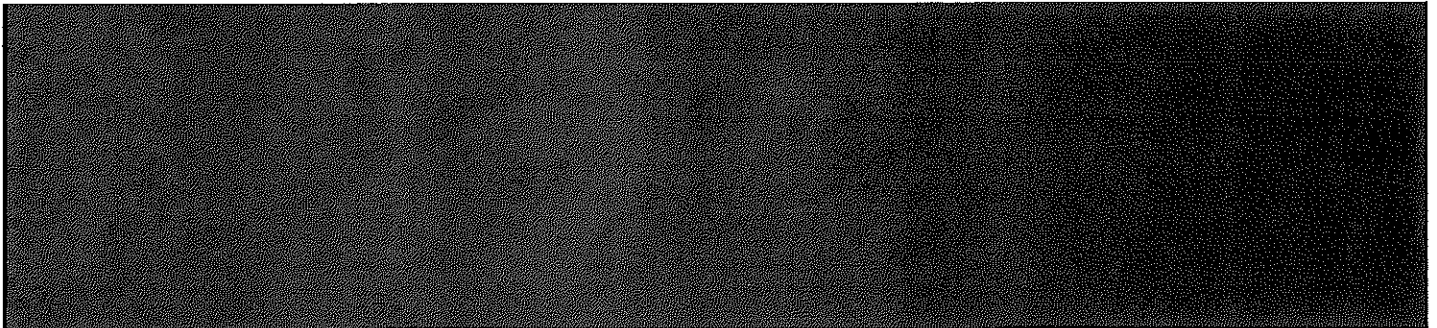

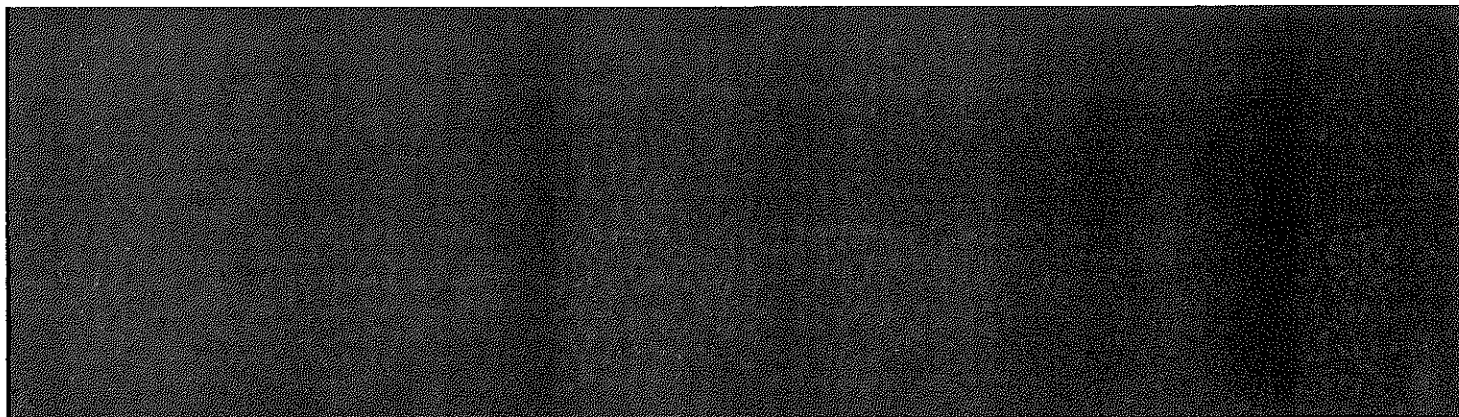
