Good afternoon,

I would like to present a few reports to both township representatives on behalf of the emergency squad so we are all comparing the same information. Due to the recent announcement of Riverside switching EMS services, there have been a number of conversations and request for information from EMS. Anyone from outside the townships and our organization that request information regarding our response times are referred to the county for an OPRA request as we will not release this information. However, it is important for you to have it.

I am attaching four reports for your review. I think they are self explanatory but I would be willing to further explain if anyone has any questions.

The chute time report shows that we are the same getting out the door for Riverside as we are with Delran. Where as our response time to Riverside is 5.03 vs the time of 6.32 for Delran. In addition, our scene time in Riverside is 12.96 average and 13.34 in Delran. Our average times for year to date show better to Riverside.

The three reports are for calls that we responded to and answered them, not the ones we missed. I have included a report for scratched calls for year to date. This displays the number of calls that were handled by mutual aid, where the concern for longer than normal wait times for the ambulance may exists. You can see we have addressed the need by adding a second ambulance in the spring and the majority of calls that we relay on mutual aid are due to us being on another call within the townships.

Please take a look and let me know if you have any questions. I have been told that the report from the BCT is looking for these times, although they have not been asked of me. If a request was made, it would be referred to the county.

Good afternoon everyone,

We entered into agreements with Delran and Riverside Townships to provide emergency medical services when the organization came back on line earlier this year. We are only staffing one ambulance at this time and today we were not able to staff the ambulance with a duty crew from noon to 6pm on a weekend. I would like to thank Josie and Jimmy for both of them giving up their Sunday afternoon to make sure we are staffed.

The fact is that there are not enough volunteers that are riding and we are relying on the career staff to cover the shifts. I understand that day time coverage is hard for most of us that have full time jobs, but the fact is that there is less than a handful that have picked up evening, overnight and weekend shifts. Leaving the organization severely understaffed. The fact is that requests for EMS in Delran and Riverside are being delayed and we are relying on mutual aide agencies.

There have been a few complaints to the Townships about our response times as our duty ambulance has been out and a second request has come in and the patients are waiting up to 45 minutes for an ambulance. This needs to change.

We are scheduled to place a second ambulance on the schedule effect Sunday, April 21. This power shift will be from 10 am to 10pm. I am scheduling a shift 10am to 6pm and then a shift 6pm to 10pm. I am hoping that the 6pm to 10pm shift could be covered by volunteer members. Anyone can talk with Kendall and be placed on a template for consistency and we are always willing to break shifts if anyone is only able to cover part of a shift. That should not be a reason that an active member is not scheduling themselves on the ambulance. We will work with you.

With that said, we are going to be recruiting EMTs to work for DES. While we do not want to lose volunteers, I want to make sure that any member that does want a career position has the first opportunity before we recruit from the outside. Many of you have been the heart and soul of the organization and you still can be every though paid. There are a lot of opportunities in our vision for DES and need your help more than ever right now.

I also would like to say if you know anyone that would be a good fit for the organization, I would you encourage them to apply. They can [Apply Here](#). Starting salary is \$13.50 to start and an increase to \$14/hr once probation is completed. We will be using a number of methods to recruit staff including social media and recruiting agencies. We have been successful in the past with our recruiting techniques. So if you know anyone, please have them complete a application.

I am open for suggestions if anyone has anything to suggest. Please feel free to reach out to me or we can talk about it Thursday evening at the squad meeting. I look forward to all of us working together and getting DES back to being the powerhouse for the western part of Burlington County.

Good evening Mr. Thurman,

I would like to introduce myself to you and let you know that Mr. Hatcher, the Township Manager has forwarded your complaint to our department. I am sorry that you had to experience that delay for an ambulance when you wife was not feeling well. I am the chief administrator from EMS Consulting Services that is working with the membership of Delran Emergency Squad. I have had the ability to look into your concern and have reviewed the situation. The situation that you expressed was factual and while there is no excuse, I have some specifics for you along with our future plan to make sure this does not happen again.

Delran Emergency Squad was dispatched at 4:22pm in town for a respiratory distress call. Our duty ambulance responded to that request. At 4:26pm, four minutes later, we received your call for an ambulance. Currently we only have one duty ambulance staffed. However, at times, we are able to rely on our volunteer membership to respond to second ambulance requests. On this day at the time of your request we were not able to respond to this second request. Central Communications then tried to obtain an ambulance from Delanco for mutual aid. Delanco was not able to respond and the call for assistance then went to Willingboro. Willingboro Fire Department was available and did respond. Willingboro Fire Department transported your wife to the hospital.

Your call for an ambulance was placed at 4:26pm and the Willingboro Fire Department ambulance arrived at 5:06pm. In reviewing the events of this incident, I found that the initial call was categorized as a medical emergency and was never upgraded to a possible stroke. Since the call was only determined to be a medical emergency from the caller, Central

entire email?

Communications gives each EMS agency 12-17 minutes to put an ambulance on the street. Since Delran Emergency Squad was not available, resulted in the use of mutual aid from our surrounding communities. This is a common practice as emergency medical services continue to get busier. I have had a discussion with the Chief of the communication center and changed our dispatch protocol to allow the call to mutual aid in eight minutes for non-life threatening illnesses and immediate call to mutual aid and the fire department for anything life threatening, such as a cardiac arrest. This will allow EMS resources to get onto location faster than you experienced.

As part of the commitment to the residents, Delran Police Department and Delran Fire Department have first responders trained in CPR and basic life support skills to initiate life saving techniques if necessarily while waiting for an ambulance. I have shared your experience with the police department and we discussed how to improve the system and decrease wait times when our duty ambulance is unavailable . We will be placing a second ambulance in service starting April 21 from the hours of 10am to 10pm to make sure we are able to provide prompt and superior care to our residents. We want to make sure that Delran Emergency Squad is there and able to help in the time of need.

I am sorry for this occurrence and can assure you that we are making changes to improve our organization. We will be hosting a Delran Emergency Squad Open House in the spring and we would love it if you were able to stop by that day to see the many good things we are doing for the community. If you have any additional concerns or would like more information, please do not hesitate to contact me.

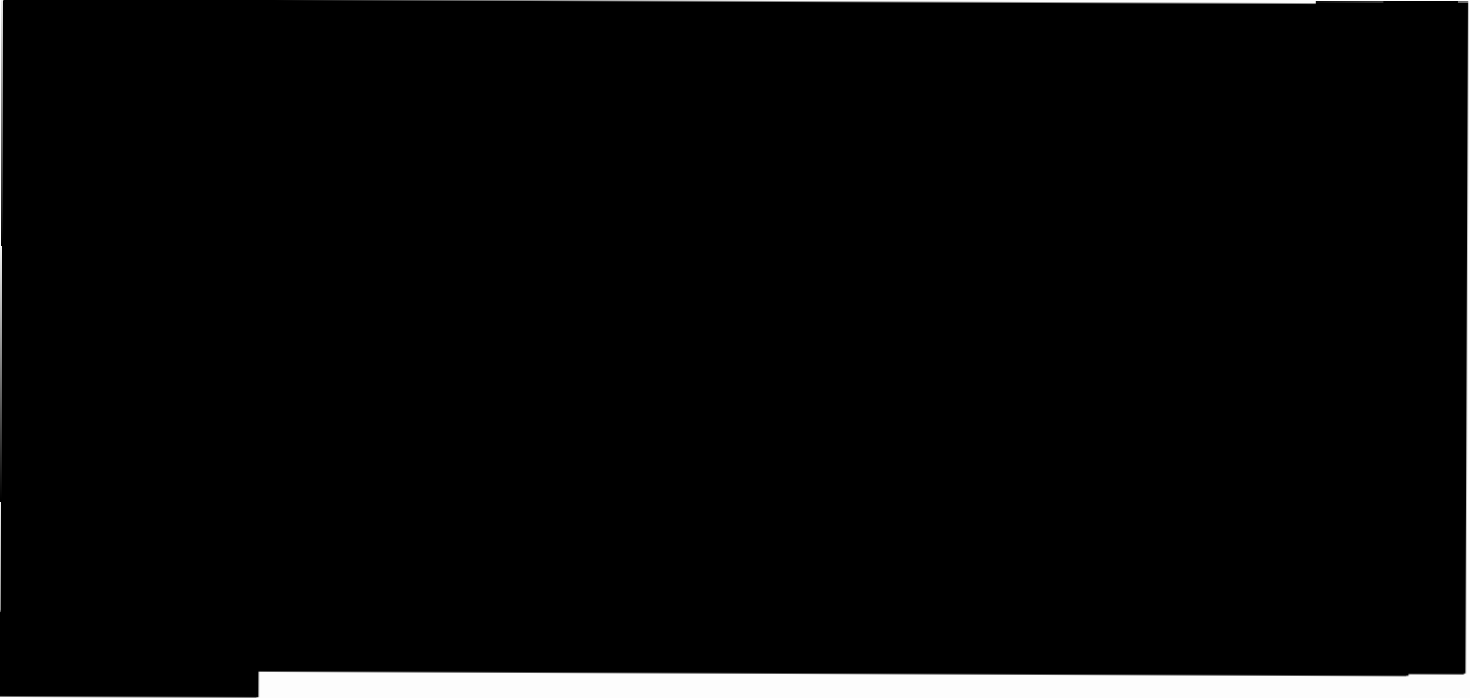
