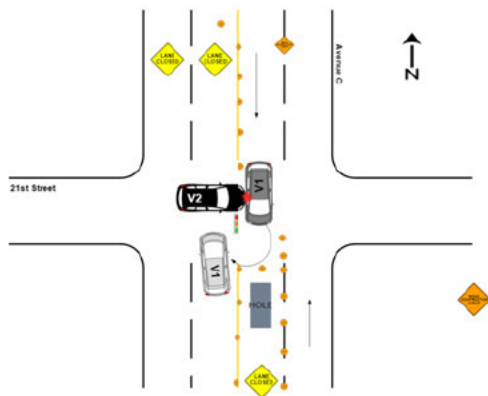

145. Crash Description/Narrative

On Friday, May 16, 2025 at 0732 hours, I responded to a crash on the intersection of 21st St and Avenue C. At the time of the crash, the weather was clear and the road surface was dry.

Unit 1, Vehicle - Silver Nissan Sentra, Going Straight Ahead
Unit 2, Vehicle - Black Nissan Rogue, Going Straight Ahead

{Driver Statements}

The Driver of Vehicle 1 stated that while driving South on Avenue C, she struck Vehicle 2 who had ran the red light at the intersection of 21st Street and Avenue C.
The Driver of Vehicle 2 stated that she was distracted by speaking to her friend, unaware of the traffic signal, and continued through a red light, leading to being struck by Vehicle 1.
