145. Crash Description/Narrative

Driver of V1 explained they were heading South from the Costco parking lot to the CVS parking lot crossing Goldsborough Dr. Driver of V1 stated another vehicle waved for them to proceed so they started through the intersection. They continued heading toward the CVS parking lot when they collided with V2.

Driver of V2 explained there were driving East on Goldsborough Drive. When approaching the intersection of Goldsborough Drive/Costco Parking Lot (Entrance and Exit) they slowed down because there was congestion of vehicles. When proceeding through the intersection, Driver of V2 observed V1 traveling south through the intersection towards them as the collision happened.

It should be noted there is a painted arrow for "Right Turn Only" on the roadway not allowing vehicles to travel South from the Costco parking lot to the CVS parking lot through the intersection of Goldsborough.

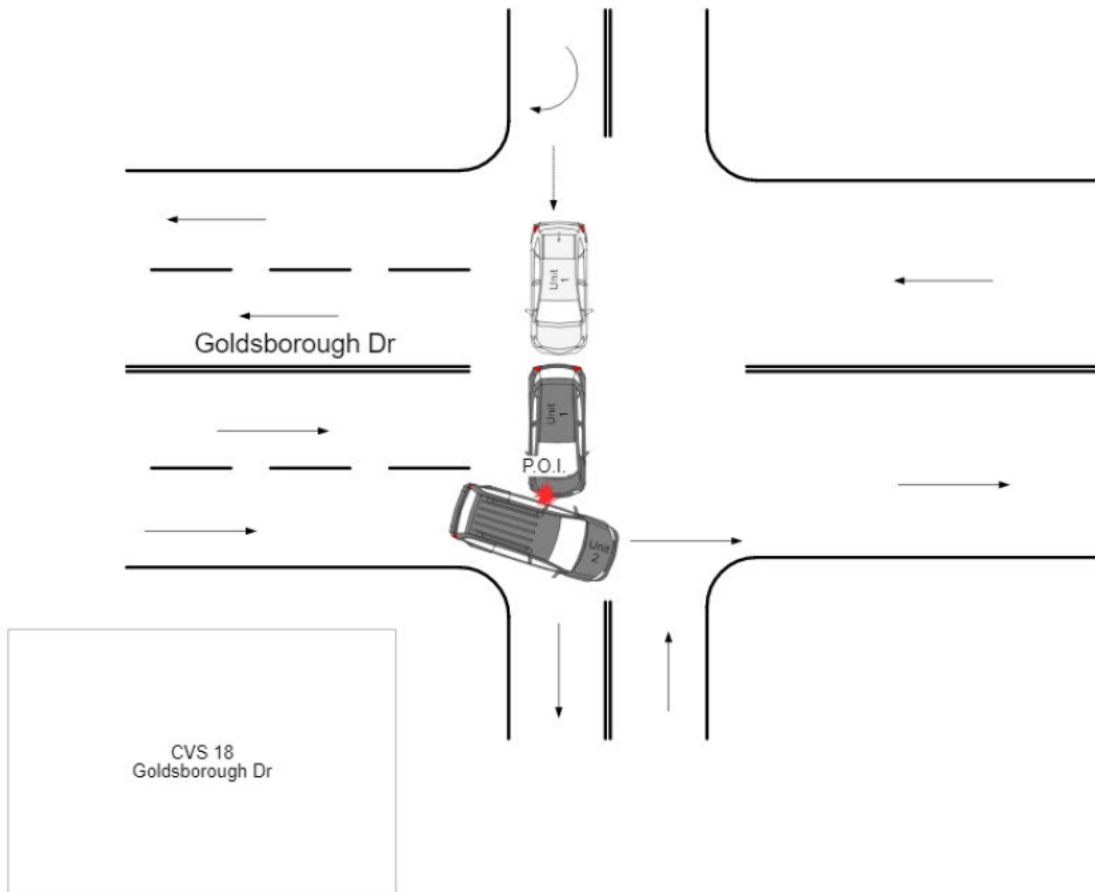
