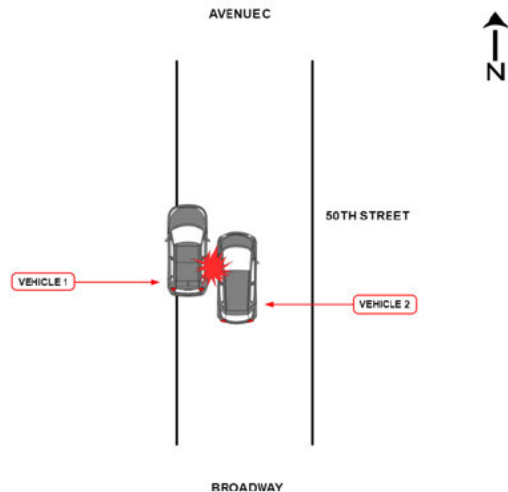

145. Crash Description/Narrative

The owner of vehicle 1 stated that her vehicle was parked on west 50th street when it was sideswiped by a vehicle that was travelling westbound.

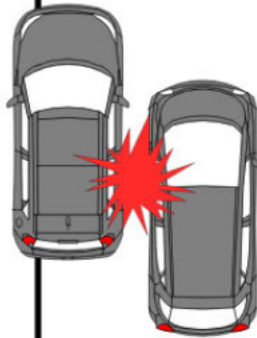
