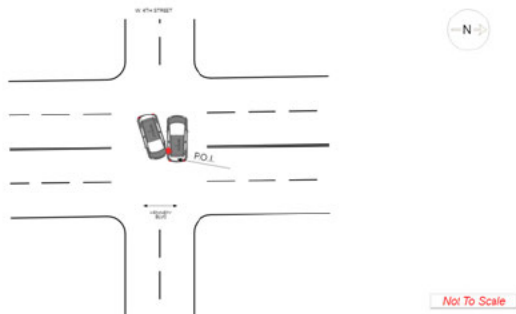

145. Crash Description/Narrative

On Sunday, May 18th, 2025, at 1749 hours, I responded to a crash on 4th Street and Kennedy Blvd. At the time of the crash, the weather was clear, and the road surface was dry. Driver 1 stated he was driving straight on W. 4th Street when he was struck by vehicle 2 who was attempting to make a left turn onto Kennedy Blvd. Driver 2 stated he was attempting to make a left turn onto Kennedy Blvd and did not observe vehicle 1 who had the right of way and was also passed the intersection.
