I am in receipt of your recent OPRA request, whereby you requested the following:

Currently, your request fails to identify with reasonable clarity the specific government records sought, as is required by Bent v. Stafford Police Department, 381 N.J. Super. 30, 37 (App. Div. 2005). A proper request under OPRA must identify with reasonable clarity those documents that are desired, and a party cannot satisfy this requirement by simply requesting all of an agency's documents. At this time, we are requesting clarification of your OPRA request. Specifically, your above list contains nicknames, such as "Teddy" and "Bill", and does not provide middle initials, addresses or other identifiers that would enable us to verify that we are providing the correct documents. The Burlington County Emergency Services Training Center has a significant number of students with the same first and last names in our database and as such, we are requesting additional information in order to be able to properly respond to your request. Please respond in writing by email to Deanna Perez at dperez@co.burlington.nj.us and provide full names, including a middle initial so that we may process your request. Failure to provide written clarification of your request by April 14, 2023 will result in the closure of this OPRA request.

I am also obligated to inform you that if you believe I have erred in withholding documents, you have the right to bring an action in the Superior Court of New Jersey, or to appeal to the Government Records Council.
