Dear Ms. Duignan:

As the Official Records Custodian for Logan Township, I received your Open Public Records Act (OPRA) request on December 16, 2022. The seven (7) business day deadline to respond to your request was December 28, 2022. On December 19, 2022 you were notified that an eleven (11) day extension, until January 13, 2023 was needed to fulfill your request. This response to your request is being provided to you on the eleventh (11th) business day of the 11-day extension.

Emails regarding trash, 5 pages

There are no other government records pertaining to your OPRA request.

These records are being transmitted to you via email, as per your request. Pursuant to N.J.S.A. 47:1A-5.b., the cost associated with this request is waived since the records are being provided by email.

If your request for access to a government record has been denied or unfilled within the (7) business days required by law, you have a right to challenge the decision by Logan Township to deny access. At your option, you may either institute a proceeding in the Superior Court of New Jersey or file a complaint with the Government Records Counsel (GRC) by completing the Denial of Access Complaint Form. You may contact the GRC by toll-free telephone at 866-850-0511, by mail at P.O. Box 819, Trenton, NJ 08625, by e-mail at grc@dca.state.nj.us, or at their web site at www.state.nj.us/grc. The GRC can also answer other questions about the law.

All questions regarding complaints filed in Superior Court should be directed to the County Clerk in your County.
