As such, the seven (7) business day deadline to respond to your request is April 23, 2020. A response is being provided to you on the 5th business day which is today, Tuesday, April 21, 2020.

Your OPRA request sought access to the following:

The GRC can also answer other questions about the law. All questions regarding complaints filed in Superior Court should be directed to the Court Clerk in your County.
