145 Crash Description/Narrative

Vehicle 1 was traveling in the wrong direction on Route 35 south when it left the roadway and struck a utility pole. The utility pole was located along the west side of the roadway, just south of the intersection of Reese Ave. The female passenger was located outside of the vehicle, lying on the shoulder of the roadway near the passenger door. The driver of vehicle, who attempted to flee the scene on foot was located down the street and around the corner from the crash lying in the driveway of 113 Vance Ave. Both occupants of vehicle suffered significant injuries and were transported to area hospitals for treatment. The vehicle sustained major damage to the front 12 o'clock position and was towed from the scene by Accurate Towing pursuant to Johns Law. The driver was charged with the following:

Driving under the influence - 39:4-50

Leaving the scene of a crash with injury - 39:4-129a

Careless driving - 39:4-96

Reckless driving - 39:4-97

Wrong way one a one way - 39:4-85.1

Failure to wear a seatbelt - 39:3-76.2f
