145. Crash Description/Narrative

V1 was traveling North on S. Lawrence Ave.

V2 was pulling out from a business parking lot attempting to go South on S. Lawrence Ave.

D1 stated that as they were driving D2 pulled out too far causing D2 to side swipe D1.

D2 stated that D1 was driving to close into the left lane so when pulling out it caused the two vehicle to side swipe.

The on-scene crash investigation revealed that D2 was attempting to merge into traffic from the private lot and steered into V1's path of travel. This caused D2 to sideswipe D1, making D2 responsible for the cars colliding.
