D2 was transported to RWJUH for further medical treatment.

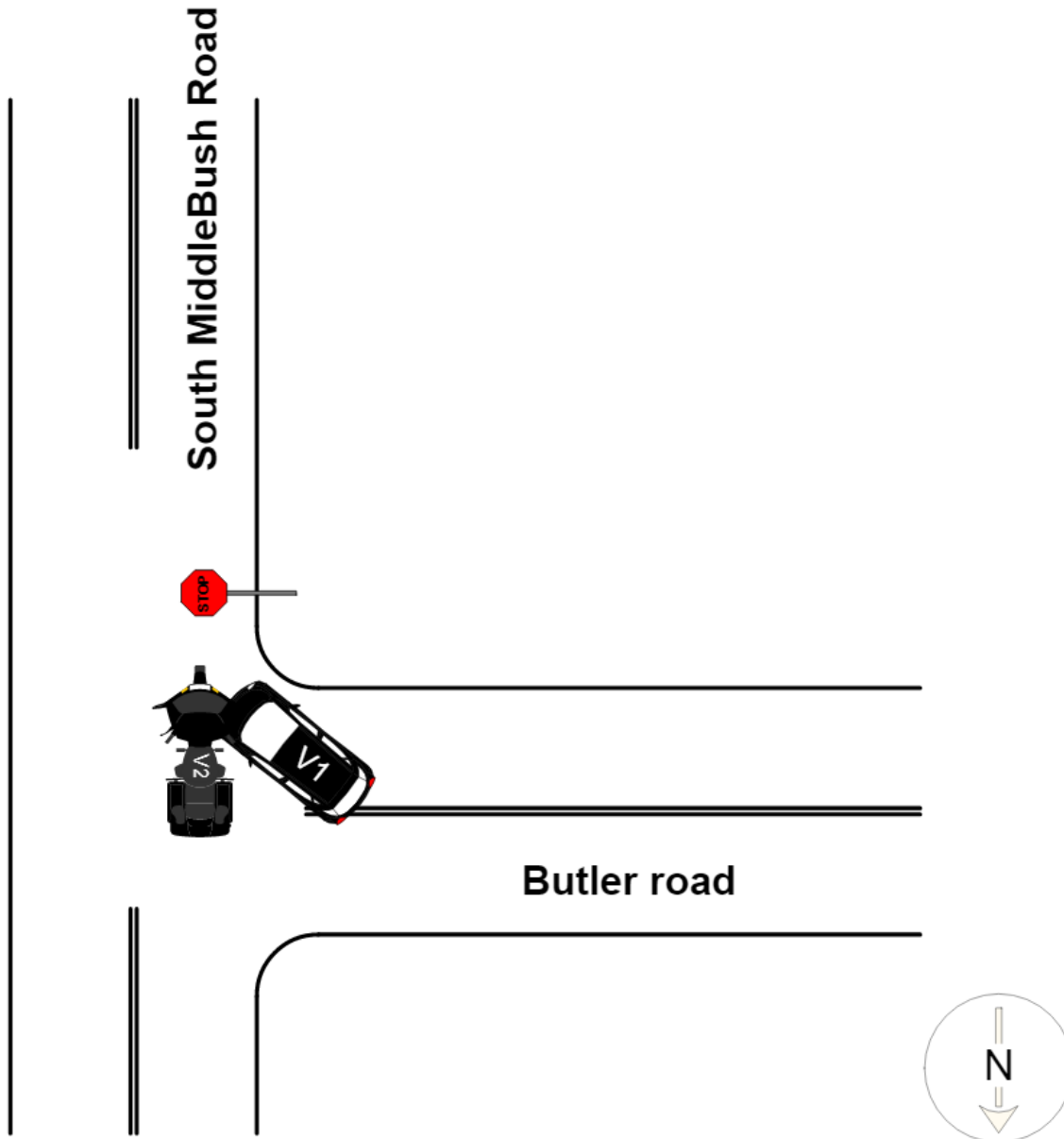
