Crash was witnessed by Michael Greengarten 201 961 4818. After crash D1 described as Hispanic male in his 50's waved at witness as he drove by. Vehicle described as a grey dump truck with furniture in the back and no rear plate. Witness followed vehicle for a short time and noticed no rear plate. Last seen SB on South Middle Bush Lane. NFI.
