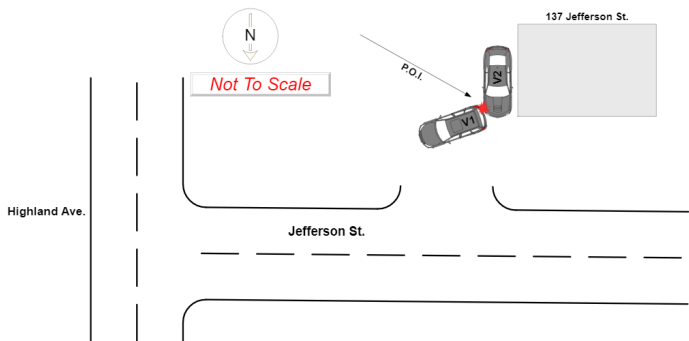

145. Crash Description/Narrative

V1 struck V2 while backing

D1 advised he was backing out of his driveway when he struck V2. D1 advised he did not see V2 while backing. D1 advised he had no injuries and did not need medical attention. V1 had minor damage to the rear of the vehicle.

RO2 advised he was in his residence when V2 was struck by D1. RO2 advised V2 was parked in his driveway. V2 had minor damage to the front of the vehicle.
