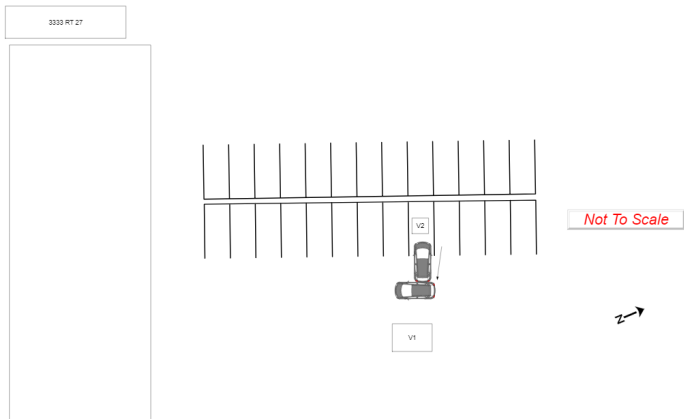

V1 WAS TRAVELING SOUTHBOUND IN THE PARKING LOT OF 3333 RT 27 (STOP AND SHOP) WHILE V2 WAS BACKING OUT OF A PARKING SPACE AND STRUCK V1. D1 RELATED V2 BACKED INTO HIM CAUSING MINOR PAINT SCUFF. D2 RELATED SHE PULLED IN THE SPACE, THEN BACKED UP TO STRAIGHTEN HER VEHICLE AND SHE DID NOT OBSERVE V1. INVESTIGATION REVEALED SAME. D2 BACKED UNSAFELY.

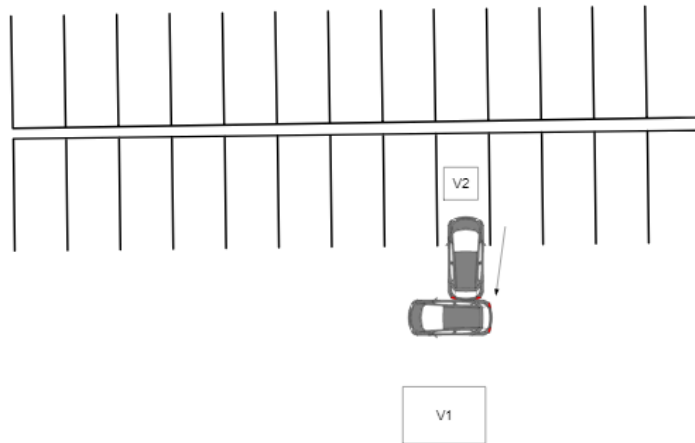
