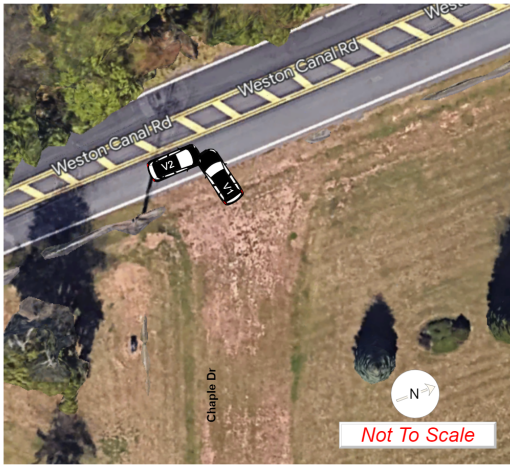

Vehicle 1 - Black Volkswagen Tiguan, Making Left Turn
Vehicle 2 - White Toyota Camry, Going Straight Ahead

D1 stated she was exiting Chaple Dr to make a left on Weston Canal Rd when she thought the road was clear and struck V2.

D2 stated he was driving straight on Weston Canal Rd when V1 came from his right side and struck his vehicle.

My investigation showed that V1 was not paying attention and struck V2.
