V1 and V2 EB on Hillcrest Ave when V1 passed on the right and struck mailbox and V2. D2 stated he was about to turn into his driveway 83 Hillcrest Ave when V1 passed him on the right and struck him. D1 stated he passed V2 on the right, realized he was turning right and swerved right to avoid contact. D1 stated he struck the mailbox 83 Hillcrest and V2. D1 improperly passed on the right and caused the crash. V2 was placed in the driveway by D2's son who arrived on scene prior to my arrival.
