145. Crash Description/Narrative

V1 and V2 NB on Franklin Blvd when V1 struck V2 from behind. D1 stated she had an eye infection and couldn't see. She also stated she "is blind" and is "supposed to be wearing glasses". As per D1 she was going straight and could not see, she impacted V2 and never saw him. D2 stated he passed the entrance to his parking lot, stopped, put vehicle in reverse, saw V1 coming, put vehicle in drive then impact occurred.
