V1 was traveling on Millstone Rd attempting to make a left turn on to Route 27.

V2 was traveling on Route 27.

D1 stated that while attempting to make a left turn, he did not see the oncoming car in the far lane causing the two vehicles to collide.

D2 stated that while traveling straight on Route 27 D1 pulled out into his lane causing the two vehicles to collide.

The on-scene crash investigation revealed that D1 did not properly yield to the right of way and was responsible for the crash.
