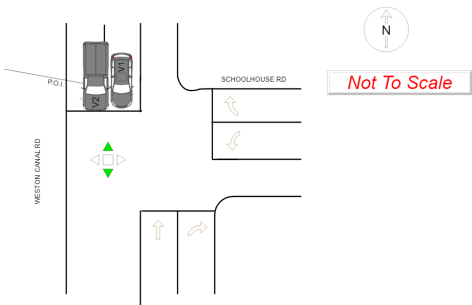

D1 STATED SHE WAS STOPPED AT THE LIGHT TO MAKE A LEFT TURN ONTO SCHOOLHOUSE RD FROM WESTON CANAL RD WHEN V2, A LARGE PICKUP TRUCK. STRUCK HER PASSENGER SIDE MIRROR AND FLED THE SCENE.

D1 WAS NOT ABLE TO OBTAIN ANY INFORMATION ON V2 AS IT FLED BEFORE SHE COULD GET IT. I CANVASSED THE AREA FOR V2 AND DID NOT LOCATE ANY VEHICLE MATCHING THE DESCRIPTION, A LARGE GREY OR BLACK PICKUP TRUCK.

INVEST: V2 STRUCK V1 WHILE PASSING AND FLED THE SCENE.
