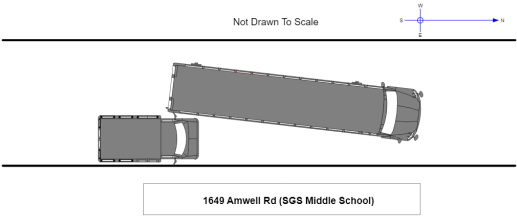

145. Crash Description/Narrative

Crash occurred in front of 1649 Amwell Road (Samson G Smith School). Vehicle 2 was parked in front of the school with the bus driver sitting in the front seat. Vehicle 1 attempted to pull in front of Vehicle 2 and struck vehicle 2's front driver's side quarter panel and driver side mirror.

Driver one stated the rear end of the bus swung around and struck vehicle 2 while he was parking.

Driver of bus 2 stated she was parked and vehicle one struck her.

Evidence shows driver one cause this crash.

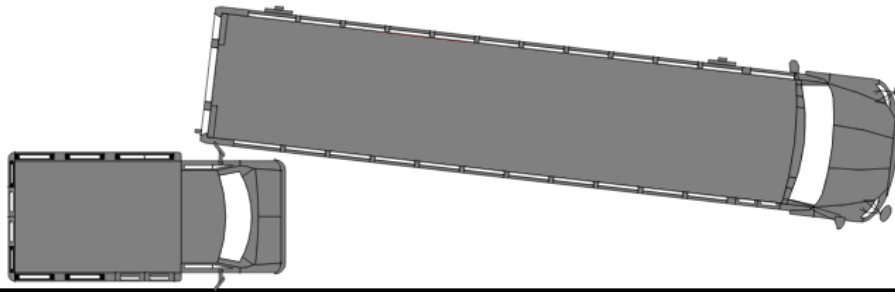
