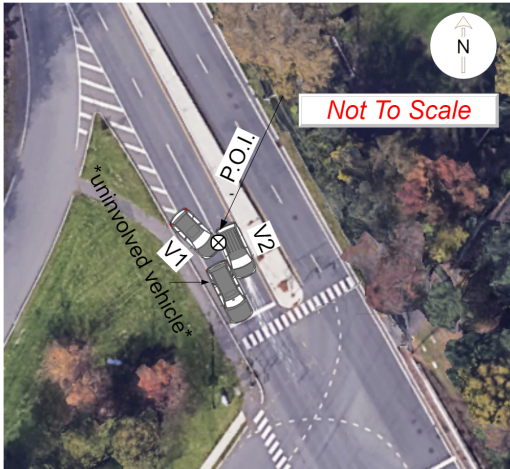

145. Crash Description/Narrative

On Friday, September 15, 2023 at 1515, Ward, Joshua responded to a crash on Easton Avenue and Demott Lane. At the time of the crash, the weather was clear and the road surface was dry.

Unit 1, Vehicle - White Audi Q3, Changing Lanes
Unit 2, Vehicle - Silver Honda Odyssey, Going Straight Ahead

{Driver Statements}

D1 stated that there was an uninvolved disabled vehicle in front of her so she intended to change lanes to go around. D1 stated that she waited until she saw a gap and then began changing lanes. D1 stated that V2 then passed her and she struck his vehicle.

D2 stated that while going straight, he saw V1 attempting to merge into him. D2 stated that he attempted to get V1's attention by utilizing his horn which he said did not work and V1 stuck him while he was passing.

{Conclusion}

Through my investigation, I determined that V1 caused this crash by improper lane change.
