On Friday, September 15, 2023 at 1945, Ward, Joshua responded to a crash on 500 Feet S of New Brunswick Road and Davidson Avenue. At the time of the crash, the weather was clear and the road surface was dry.

Unit 1, Vehicle - Gray Subaru Outback, Going Straight Ahead

{Driver Statements}

D1 initially stated that he hit the telephone pole. D1 then stated that he swerved to avoid hitting a deer and then struck the telephone pole. D1 changed his story again and stated that he struck a deer in the roadway and not the telephone pole. It should be noted that there was no evidence to suggest that V1 struck a deer. Let it be noted that D1 was arrested for suspicion of DUI.

{Conclusion}

Through my investigation I determined that D1 caused this crash by failing to keep right.
