145. Crash Description/Narrative

V1 was attempting to reverse out of a parking spot.

V2 was parked in a parking spot.

D1 backed up and struck the rear of D2. After striking the vehicle, D1 drives off.

It should be noted that D2 drives a Tesla and was able to capture the incident on the Tesla's cameras. The camera footage was recorded via my Body Worn Camera. In the footage you can see a silver Lexus RX, bearing NJ registration A35H2B, back up and hit the rear of V2. After striking V2, D1 gets out of his Lexus and walks up to V2 to observe the damage. After acknowledging that there was damage, D1 gets back into his vehicle and drives off.

D2 was inside of the facility and got an alert via his cellphone that his parked vehicle was struck.

A full-registration query was conducted for V1, and it was discovered that the R/O of V1 resides in Edison. Edison Police department was contacted, and they advised officers attempted to contact R/O but resulted in no response to the door.

A request for further action has been filled out so that the summons could be mailed to D1's residence.

10/19/2023: It should be noted that the driver of V1 came to FTPD headquarters and dropped off the insurance for V1 as well as the driver license for D1. All information has been updated into this report.
