D1 RELATED THAT SHE WAS STOPPED IN TRAFFIC ON EASTON AVE NORTHBOUND WHEN V2 REAR-ENDED V1. D1 RELATED THAT D2 INDICATED THAT HE WAS NOT LOOKING IN FRONT OF HIM AT THE TIME OF THE CRASH.
