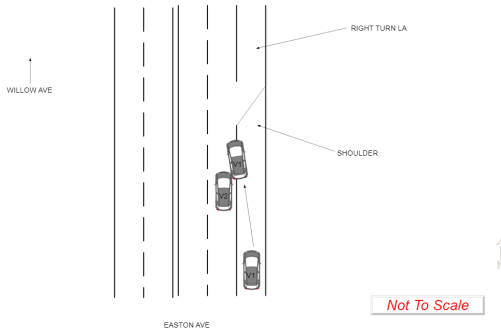

DRIVER 1 STATES HE WAS CHANGING LANES FROM THE SHOULDER INTO THE NB LANE OF EASTON AVE WHEN HE WAS STRUCK BY VEH 2. DRIVER 2 STATES HE WAS NB ON EASTON AVE WHEN VEHICLE 1 ENTERED HIS LANE OF TRAVEL WITHOUT WARNING AND STRUCK HIS VEHICLE.

INVEST: VEHICLE 2 WAS NB ON EASTON AVE IN RIGHT LANE IN HEAVY TRAFFIC. VEHICLE 1 WAS NB ON EASTON AVE IN THE SHOULDER(RIGHT). DRIVER 1 ATTEMPTED TO ENTER THE RIGHT NB LANE BUT DID SO DIRECTLY IN THE PATH AND WITHOUT WARNING TO VEHICLE 2.
