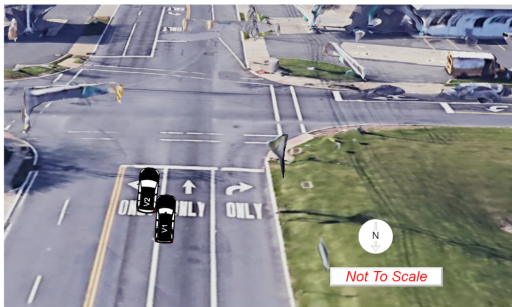

Vehicle 1 Black Ford Edge, Going Straight Ahead
Vehicle 2 Gray GMC Ut, Making Left Turn

D1 stated she was waiting at the red light when V2 hit her as he was trying to make a left turn at the traffic light.

D2 stated he was stopped at the red traffic light in the left lane when V1 struck him.

My investigations showed that V1 was not paying attention while she was approaching the traffic light and struck V2.
