Vehicle 2 was traveling on Canal Road.

Vehicle 1 was stopped on Bunker Hill Road at a posted stop sign.

Vehicle 1 then attempted to turn left onto Canal Road and crashed into Vehicle 2.

Driver of Vehicle 2 stated Vehicle 1 entered the intersection while she was driving and struck her vehicle.

Driver of Vehicle 1 stated he did not observe Vehicle 1 traveling prior to entering the intersection.

The investigation revealed that Vehicle 1 failed to Vehicle 2 who had the right of way.
