V1 WAS TRAVELING ON EASTON AVENUE. V2 WAS TRAVELING ON EASTON AVENUE. V1 STRUCK V2.

D1 TOLD ME HE WAS TRAVELING ON EASTON AVENUE AND REAR ENDED V2 BECAUSE SHE BRAKED SUDDENLY.

D2 TOLD ME SHE WAS TRAVELING ON EASTON AVENUE AND WHILE SHE WAS STOPPED FOR TRAFFIC, SHE WAS REAR ENDED BY V1.

INVESTIGATION REVEALED V1 CAUSED THE CRASH IN THAT HE WAS FOLLOWING TOO CLOSE AND STRUCK V2.
