DRIVER OF V1 STATED HE WAS DRIVING ON WORLD FAIRS DRIVE WHEN V2 CAME TO A STOP. DUE TO THE SUN'S GLARE, HE WAS UNABLE TO DETERMINE WHETHER THERE WAS A SIGNAL INDICATING V2 ATTEMPTING TO MAKE A LEFT TURN. BY THE TIME HE REALIZED THIS, IT WAS ALREADY TOO LATE AND A COLLISION OCCURED WITH V2.

DRIVER OF V2 STATED THAT WHILE DRIVING ON WORLD FAIRS DRIVE, HE TRIED TO TURN LEFT INTO A PARKING LOT WHEN V1 COLLIDED WITH THE BACK OF HIS BUMPER.

INVESTIGATION REVEALVED DRIVER OF V1 CAUSED THE CRASH DUE TO DRIVER INATTENTION.
