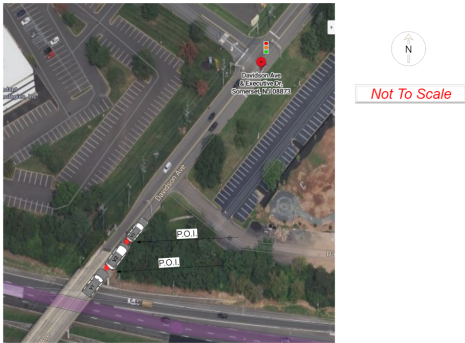

V1 struck V2 which struck V3

D1 advised he was slowing down in traffic and hit the gas pedal. D1 advised he accelerated and struck V2, subsequently striking V3. D1 advised he was unsure if the traffic signal was red or green. D1 advised he no injuries and did not need medical attention.

D2 advised he was slowing down in traffic and he was struck by V1. D2 advised V1 struck V2 which caused V2 to strike V3. D2 advised the light turned green and he kept his foot on V2's brakes due to traffic. D2 advised he no injuries and did not need medical attention.

D3 advised the traffic signal turned green, but due to traffic he remained stopped in traffic. D3 advised V1 struck V2 and V2 struck V3. D3 advised he no injuries and did not need medical attention.

D1 caused the crash due to not being attentive.
